- Why are you running for Town Council, and what skills or strengths will you bring to the position?*

Judy is an incumbent on the Council and responded to the last questions pertaining directly to incumbents:

7. *If you are an incumbent, please respond to these questions regarding your previous term:*

- a. *What do you think is needed to move Town Council to a higher level of effectiveness?*

When we are elected to serve the people of Altadena, each council member focuses on the needs of his area and the concerns of those citizens residing in the area he serves. But, over the past two years, I have come to realize that what affects one census tract affects all of us. For us to achieve a higher level of effectiveness, it is important for us to act collectively and strategically on key issues that are a common concern for all constituents.
